Dear Putnam County Journeyman:

Enclosed you will find an application for the renewal of your Putnam County Journeyman License for September 2010 – September 2012. Please note that this is a two (2) year license and the fee for the 2 year license is \$100. Your current card is only valid until September 30th.

**IMPORTANT: A late fee of \$25 will be assessed on any application received after October 15, 2010. As well, if your Journeyman License is not renewed by December 31, 2010, you will lose the ability to renew your license. After that date, you will then have to reapply for the Journeyman License, meet all the necessary qualifications and pass the Journeyman exam.**

Please return your renewal application and child support certification form, before September 30, 2010, along with the \$100 fee made payable to Putnam County Commissioner of Finance. **Both forms must be completed and notarized.** Incomplete applications will be returned unprocessed.
