WHEREAS, the 2008 legislation had a negative impact on New York State by limiting capital that could be invested to develop infrastructure, create jobs, provide early stage seed funding, create workforce development programs, and increase downtown revitalization: and

WHEREAS, several IDAs have reserves that could be directly invested in local communities to stimulate economic growth; and

WHEREAS, IDAs worked collaboratively with the Office of State Comptroller (OSC) on groundbreaking legislation in 2016 to improve reporting, transparency, and accountability; now therefore be it

RESOLVED, that the Putnam County Legislature supports legislation authorizing IDAs to use the funds they have to provide loans and grants within their regions to create jobs, leverage private investment, and improve the economic climate and quality of life across New York State; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature shall forward copies of this resolution to Governor Andrew M. WHEREAS, it is fitting that Putnam County continues to modernize and improve its senior centers to make them an even better place for our seniors to socialize, stay connected, and keep healthy; and

WHEREAS, Putnam County has entered into a lease agreement for use of the Lahey Pavilion at the former Butterfield Hospital Center site in the Village of Cold Spring; and

WHEREAS, this space will be used to house the Putnam County Office for Senior Resources' new state-of-the-art Senior Center serving the residents of the Town of Philipstown; and

WHEREAS, the Rules, Enactments & Intergovernmental Relations Committee has considered names for this new Senior Center facility; and

WHEREAS, the Rules Committee approved the name "Friendship Center in Philipstown"; now therefore be it

RESOLVED, that the Putnam County Legislature does hereby officially name the Senior Center located in the Lahey Pavilion in the Town of Philipstown the "Friendship Center in Philipstown".

Chairman Castellano recognized Legislator Albano, Chairman of the Physical Services Committee. On behalf of the members of the Committee, Legislators Nacerino and Scuccimarra, Legislator Albano moved the following:

Legislator Albano stated that these are additional funds to complete the work needed at the Senior Center in Philipstown that was not part of the original proposal, such as; the kitchen equipment and furnishings. He provided some background on the project stating that the original estimates came in as high as \$1.8 million. He explained that the Highways & Facilities department performed some of the renovations which resulted in a savings. Legislator Albano read the following letter into the record submitted by the County Executive:

"I wish to thank my colleagues on the Legislature, most notably Legislator Barbara Scuccimarra, for approving the final funding for the Friendship Center in Philipstown. Your commitment to this wonderful project exemplifies the finest of leadership in government. As elected officials, our responsibilities are many. Most important being health and safety, and always staying focused on responsible fiscal management. For many years we have worked side by side to fight for the people of Philipstown and Cold Spring who deserve a beautiful, state of the art facility that we know will be enjoyed by our seniors today and by future generations.

As long as I have been a public servant in county government, as a Legislator and now as the County Executive, the taxpayers, particularly our seniors, have been sorely underserved in having convenient access to county services in the western side of

Putnam County. To say this Friendship Center in Philipstown is overdue is an understatement for sure. Our senior population is trending high in Putnam County and in New York State. The numbers for tax contribution by the residents of the western part of the county and the services being available are nowhere compatible.

Tonight, we stand together to change just that. It is my wish for this facility to be available and open to all the services that our county government provides. It's important that we look at this location as a satellite site for our Health Department to set up immunization pods, wellness and health checks, and to provide mor county services that are only available on the eastern side of our county.

I look forward to the day we all "cut the ribbon" and live up to our pledge as elected officials to make sure that we serve all the people of Putnam County to the very best of our abilities."

MaryEllen Odell Putnam County Executive

Legislator Scuccimarra reminded everyone that \$500,000 was allocated through our Legislative Representatives; \$250,000 from Assemblywoman Galef and \$250,000 Senator Serino. She explained that she is still looking into other venues for additional funding.

Legislator Nacerino stated that in addition to being stewards of taxpayer monies, the Legislature's primary function is to also protect, preserve the safety and welfare of our residents. She explained that providing a senior citizen center on the western side of the County, where resources are very limited, certainly enhances the senior citizens quality of life in the Town of Philipstown and the Village of Cold Spring. She stated that she is happy to support this project.

Legislator Albano explained how the cost of projects can grow exponentially due to surprises that can arise. He explained that with this project, if you back out the furniture, fixtures and kitchen, he believed that there might only be a 10% overage of the original estimate. He stated that he was proud of this project and looked forward to its completion.

Legislator Sayegh stated that the shortfall of the project is 10% of the construction budget which she believed to be well within reason. She stated that this additional amount includes kitchen equipment, furniture, fixtures and other equipment. She stated that it also includes a 5% contingency; therefore she believed that the County was well prepared.

Chairman Castellano explained that the seniors that live on the western side of the County are underserved. He believed this senior center would be a great opportunity for them. He stated that he wholeheartedly supported this amendment.

WHEREAS, pursuant to Resolution # 207 of 2015 the Putnam County Legislature agreed that an amendment to the Deed of Conservation Easement would be beneficial and required to further the County's goals and objectives while serving to strengthen the existing easement and improve its effectiveness and enforceability; and

WHEREAS, the County and WAC have since negotiated an Amendment to the Deed of Conservation Easement which will further the County's goals and objectives while serving to strengthen the existing easement and improve its effectiveness and enforceability; and

WHEREAS, the proposed Amendment to the Deed of Conservation Easement will modify the original boundaries of certain Use Areas located within the Tilly Foster Farm property, which were originally described in the Deed of Conservation Easement and depicted on the Conservation Easement Survey; and

WHEREAS, both the Putnam County Attorney and the Putnam County Department of Highways and Facilities have reviewed the proposed Amendment to the Deed of Conservation Easement (a copy of which is attached hereto and made a part hereof as Exhibit "A"), and have determined same to be acceptable; now therefore be it

Legislator Jonke explained that this resolution is in response to NYSEG's failure to adequately respond during the March storms. He thanked Legislator Sayegh for bringing this forward.

Legislator Gouldman stated that he was very supportive of this resolution and was glad this Legislative body was taking a stand on this. He explained that in addition to the action which the Legislature is taking, every resident has the opportunity to express their concerns on their experience with NYSEG's response. He directed these individuals to visit the public service commission website at www.dps.ny.gov. He stated to enter the case number 18/00618 in the search option found on the homepage. After the case is open, access the screen to enter complaints by clicking the "post comments" tab located at the top of the page. He asked that comments be made by Tuesday, May 22, 2018.

Legislator Albano believed that we were all on the same page. He stated that, in his opinion, there was plenty of manpower with a lot of trained individuals, however, he believed that the management and coordination was lacking on NYSEG's part.

Legislator Sayegh believed it was important to bring this forward as a Legislature to speak on behalf of the constituents that we represent; many who were devastated by the storms. She explained that the resolution also goes as far as asking NYSEG to reimburse certain costs to our citizens and Putnam County for the extensive emergency services costs due to the poor handling of the storm recovery including: any costs of opening and operating warming centers, dry ice / bottled water distribution centers and to help residents without power. She stated that she is very much in favor of this on behalf of all residents in Putnam County.

APPROVAL/SUPPORT INVESTIGATION OF NYSEG'S RESPONSE TO WINTER STORMS AND REGISTER COMPLAINT WITH NYS DEPARTMENT OF PUBLIC SERVICE

WHEREAS, New York State Electric and Gas ("NYSEG") is the larger of the two electrical utilities providing electrical power to Putnam County residents and businesses; and

WHEREAS, NYSEG serves 38,310 customers in Putnam County;

WHEREAS, NYSEG operates without competition, leaving customers with no alternative for obtaining electricity service elsewhere; and

WHEREAS, Winter Storm Riley hit Putnam County on March 2, 2018, and Winter Storm Quinn arrived less than a week later on March 7, 2018; and

WHEREAS, these storms left thousands of Putnam County residents without electrical service for unacceptable periods of time, threatening the health, safety, and well-being of Putnam's residents – especially seniors, the frail, the ill or infirm, and the very young; and

WHEREAS, NYSEG may have failed to provide "make-safe" crews to municipalities in a timely way, to allow local highway crews to clear roadways, thereby causing prolonged blockages to primary, secondary, and tertiary roadways; and any such failures may have imperiled lives, impeded safety efforts, and hampered first-responders' ability to deal with calls for assistance in a timely manner; and

WHEREAS, NYSEG may have failed to address local critical infrastructure restoration needs in a timely way; and

WHEREAS, NYSEG failed to adequately communicate with, and provide critical information to, Putnam County's emergency services professionals and elected officials regarding outages and restoration efforts; and

WHEREAS, NYSEG may have provided incorrect or misleading information to customers regarding outages and restoration times; and

WHEREAS, pursuant to New York State Public Service Law § 71, the Putnam County Legislature is empowered to file a complaint in writing with the New York State Department of Public Service as to the efficiency of the electric supply, or as to the extent or duration of a disruption in electricity service; and

WHEREAS, upon receipt of such a complaint, the Department of Public Service shall investigate as to the cause for such complaint; and

WHEREAS, on March 14, 2018, Governor Andrew M. Cuomo announced that the Department of Public Service has formally notified the chief executives of the state's major electric utility companies that an investigation into preparedness of and response to two storms is now underway; now therefore be it

RESOLVED, that the Putnam County Legislature fully supports Governor Cuomo's direction to the Department of Public Service to conduct a thorough review of NYSEG's storm response performance, which review should include an investigation of the company's staffing, quality of response plans, communications with customers and local governments, the timeliness of calls for "mutual aid," and the timeliness of its emergency response and power restoration efforts; and be it further

RESOLVED, that the Putnam County Legislature calls upon the Department of Public Service to order rebates or rate reductions from NYSEG for lost power, loss of revenue from business closures, hotel stays, spoiled food and medications, and other foreseeable losses from extended power outages; and be it further

RESOLVED, that the Putnam County Legislature calls upon the Department of Public Service to conduct public hearings in Putnam County to hear from residents who have suffered massive inconvenience and property loss because of NYSEG's response to the storms: and be it further

RESOLVED, that the Putnam County Legislature calls upon the Department of Public Service to order NYSEG to reimburse Putnam County for the extensive emergency services costs to the County due to poor handling of the storm recovery, including: 1)

any costs of opening and operating warming centers, and dry ice / bottled water distribution centers, for residents without power; and 2) costs for overtime pay for emergency responders and employees staffing warming centers and shelters; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature shall forward a copy of this Resolution to the Governor, New York State Attorney General Eric Schneiderman, and Putnam County's delegation in the New York State Senate and Assembly; and be it further

RESOLVED, that the Clerk of the Putnam County Legislature shall cause to be filed the required form of complaint to the Department of Public Service required by Public Service Law § 71, along with a copy of this Resolution.

Item #8 - Recognition of Public on Agenda Items

Armanda Famiglietti, Town of Carmel Resident, referenced the additional \$300,000 for the Friendship Center in Philipstown, Item #6m. She questioned if there was a cap on the amount of spending for this project.

Chairman Castellano explained that this is the public comment period. He invited her to attend the Committee meetings where questions are entertained. He stated that the Legislature did allocate these funds and will do our best not to spend the full \$300,000. He believed that it was for a good cause.

Ms. Famiglietti questioned if she should go to the Physical Services Committee meeting.

Legislator Albano stated that he would speak to her after this meeting.

Liz Armstrong, from the Highlands Current stated that with the approval of the funds for the Senior Center, she questioned if that meant they could offer the contract to the lowest bidder.

Chairman Castellano explained the procedure for the comment period again.

Ms. Armstrong stated that the press doesn't usually opine on matters before a Legislative body and give personal opinions; but they do ask questions. She stated that if the contractor is the gentleman from Poughkeepsie that submitted the lowest bid, she questioned if he would use Putnam County crews as subcontractors or bring in workers from Dutchess County.

Chairman Castellano stated that he did not have an answer for that.

Lynne Eckardt, Town of Southeast expressed that this evening was a perfect example of why cross talk should be permitted. She believed that since this is the only televised meeting, it was an important time to communicate to the public.

Item #9 - Recognition of Legislators

Legislator Gouldman explained that the Putnam Valley Commuter Shuttle was launched yesterday, Monday, April 30, 2018. He stated that the bus picks up passengers at the Putnam Valley Town Park. Legislator Sullivan stated that the Lake Mahopac Rotary Club will hold their "Rock n Roll" oldies show on May 11, 2018 at the Mahopac High School. He stated that the funds raised will go to local organizations. He mentioned "Paint the Town Purple Day" which is on Friday, May 4, 2018 at 1:00 pm at the Carmel Fire Department. It kicks off the American Cancer Society "Relay for Life" fundraiser which is scheduled for June 2nd.

Legislator Nacerino wished all the moms a very "Happy Mother's Day". She also reminded everyone that May 15th are the school budget votes.

Legislator Sayegh recognized the passing of an important member of the Mahopac Falls Volunteer Fire Department Ladies Auxiliary; Mrs. Davey Jean Beska, on Monday, April 23, 2018, one day shy of her 90th birthday. She served proudly in many volunteer fire service organizations both locally and statewide. She stated that Mrs. Beska will be greatly missed by the Mahopac community.

Legislator Jonke recognize and thanked the individuals who participated in "Bob Palmer Day" in Brewster on Saturday, April 29th, by placing flags on the Veterans' graves. He explained that up until approximately seven years (7) ago when Mr. Palmer turned 90 years old, he would place flags at the graves of our Veterans every year before Memorial Day. When he turned 90 and no longer could physically do this, the community stepped up to continue his tradition. He thanked Mr. Palmer who, at 96 years old, came out on Saturday. Legislator Jonke thanked Mr. Palmer for starting this tradition in our community.
