Introduction

Scope of the collections

The Putnam County Archives was established to identify, collect, preserve, and make accessible records created by and for the government of Putnam County, its affiliated agencies, and its municipalities. The County Archives hold records that have long-term governmental, historical, and legal importance.

The County Government Archives document collection contains more than 200 series. The records begin officially in the year 1812 when Putnam County separated from Dutchess County, although numerous documents and/or copies as far back as the Revolution are also included. The archives collection arbitrarily extends 100 years to approximately 1912, but many series go through World War II and some records, e.g. the records of the County Charter Commission, may be from recent years. Records created since 1912 designated "permanent" will be added to the archives at a later date. The primary concentration of the records is the 19th Century and the early 20th Century. A directory follows this introduction. With a few exceptions, series in the county archives are open to researchers.

Also in the County Historian's Office

There are other places to turn for historical sources that are not records of Putnam County Government. The County Historian's office also maintains the Historian's Collection and the Historian's Library.

The County Historian's Library holds a collection of books, periodicals and files relating to Putnam County history and genealogy. The Library also has county newspapers (some on microfilm), microfilm and many indexes of federal censuses to 1930, microfilm of public records held in other repositories, cemetery records, and family history files and books. It is open to the public during regular office hours (9:30 to 4:00 Monday through Wednesday and other weekdays by special appointment) It is a research library but not a lending library. The Historian's Collection consists of non-governmental historical records in variety of formats. For a full description, click on <u>Historian's Collection</u> on our home page, <u>www.putnamcountyny.com/historian</u>. Briefly, the Historian's Collection consists of the following:

<u>The Document and Records Collection</u> is a variety of papers and records such as family genealogy, correspondence, diaries, scrapbooks, directories, essays, personal papers of private and political figures, business records of civic organizations, account books, indentures, deeds, certificates and historical reference.

The Map Collection documents the history of land use and ownership in the county. The collection contains more than 1000 maps, original and photocopies, from the American Revolution to present day. (Aerial photographs commissioned by the county are found in Series 147 of the County Archives.) The more frequently utilized maps are by O'Connor (1854), Beers (1867), and T.H. Reed (1876). Digitized versions are available at hvrh.org. The maps are indexed.

<u>The Photograph Collection</u> contains thousands of images dating from the mid- 19th Century to present day and includes a significant number from the files of *The Patent Trader* and *The Putnam County Courier*. The photography collection is indexed by subject, and many photos have been scanned.

<u>The Publications and Pamphlets Collection</u> (1862 to present) features government, civic, political party, and tourism brochures and is accessible through a database.

<u>The Cassette and Digital Recordings</u> Collection (audio and video) consists of oral history, special events, local events, and special programs. number of CDs and digital tapes, this part of the collection is expected to grow substantially. It is indexed in this directory.

<u>Miscellaneous Artifacts</u>, souvenirs, memorabilia, ordinarily related to archival collections.

The County Historian's Office welcomes researchers. However, students below college level should use their school or local libraries for term paper research. We do reserve the right to deny access to persons who show by their behavior that they violate the standard practices, ethics and courtesies of research inquiry. Access may also be denied for records restricted by law.

Other Historical Resources in Putnam County

A great deal of information about each town and village in Putnam County can be gathered from local governments and from local historical societies and libraries. For instance, vital records (births, marriages, and deaths) from 1880/82 are kept by town and village clerks, although some (Kent's and Putnam Valley's) are available in the Historian's Office. The town and village historians also maintain files of historical material as do the local libraries. One should also look at the holdings of the local historical societies and museums - especially, the Putnam History Museum (formerly the Putnam County Historical Society and Foundry School Museum). A Note on Court Records

The various series of court records held by the Putnam County Archives can be difficult to navigate. An 1823 critic noted that "the records of the court [NY] have never been kept in a proper state for easy recurrence, preservation, and prompt and safe removal in case of necessity." Not only did the courts themselves change as the nation matured, but the indexing and filing systems used in the county changed as well; and, without documentation of those changes, it is left to interpretation to describe the contents and connections among the various series.

The arrangement and description of these records has been influenced by the manner and timing of their receipt in the archives. Not all records of the same series were received together and at the same time. This has led to duplicate groupings and overlap of dates in multiple folders. In earlier years, filed records from different courts seem have been intermixed in the county clerk's office. This often occurred when a case was appealed from the court of original jurisdiction to a higher court.

The court records from the period before the reorganization of the courts in 1847 were received in the archives with no arrangement at all. They had been boxed for disposal in a landfill and were "rescued by the then county historian in the 1980s before state laws required their preservation. Primarily from the court of common pleas, the county court, and the supreme court, the county historian's office arranged and preserved them as well as could be done at the time, organized by court, year, term, and case.

Later court records are better arranged, sometimes even bound. Only two series have case numbers – 034 Surrogate's Court Records, Probate, and 045 Judgment Records/Roll from the Courts of Common Pleas, Supreme Court, Oyer & Terminer, and Putnam County. These records are reasonably easy to work with. Several other series – 013 Putnam County Court of Common Pleas, 1812-1848, 017 Putnam County Court Records, 046 Putnam County Court Orders and Rules, 047 Putnam County Supreme Court Civil Actions and related documents, 054 Orders of Discontinuances, are sometime possible to cross-reference. The records of the Court of Common Pleas have been indexed in COURTS.DTF and the names of the parties appear in the Names Access Database.

Outline of Courts' Functions

The following information has been abstracted and condensed from Duely & Constantly Kept, (1991), published by NYS Court of Appeals and NYS Archives and Records Administration, Albany.

New York's Supreme Court of Judicature was established in 1691 and modeled after the English court system. The Supreme Court Judges rode circuit and sat for fixed terms in any locality. It was a court of both original jurisdiction (major criminal cases, civil actions over £20 pounds, all real property actions) and appellate jurisdiction in both civil and criminal cases. After 1693 most cases were tried in county court: the court of

common pleas in civil cases and the court of general sessions of the peace in criminal cases. The jurisdiction of each court overlapped with that of the Supreme Court. To make it more confusing, the Supreme Court was a court of Oyer and Terminer when it indicted or tried a criminal case and a circuit court when it acted as a court of original jurisdiction in an important civil case. With only minor changes, this court structure continued until court reorganization in 1847.

After 1847 and the creation of the Court of Appeals, the county clerks maintained the courts' trial records. The Supreme Court (NY State) mostly reviewed the proceedings and judgments of lower courts with limited jurisdiction. These lower courts were divided into civil and criminal branches. Courts of oyer and terminer remained branches of the Supreme Court until 1896. The county courts of common pleas and courts of general sessions were replaced with county courts having jurisdiction over lesser civil and all felony cases. The changes in the county courts are reflected in Series 113, Court Minutes which identifies courts as Common Pleas 1812-1847, County Court 1848-1857, County Court and Court of Sessions 1858-1895, and County Court 1896-1936. The county judge was also the surrogate.

Until 1847, there were few changes in the town courts of justices of the peace. After 1826, they were elected in each town. (In Putnam County towns, they do not appear to have been elected until 1831.) Justices sat in minor civil cases in their towns. Three justices or a judge and two justices could sit together as a county court of General Sessions or Special Sessions in criminal matters. Their records of convictions were filed with the county clerk.

Arrangement: chronological

Description of volumes in red binders and contents of archive boxes: Record of invoices submitted by towns and individuals & 3rd parties for payment by the county government. The types of bills presented were for services of the assessor, road commissioners, election clerks and inspectors, constables for keeping and transporting prisoners, and justices of peace for examining prisoners and transporting them to jail. Other reimbursements requested were planks for bridges, damages for laying of roads, court attendance, assessments, supplies and medical expenses including those from lunatic asylums, etc. Since the records of the proceedings of the board of supervisors have been lost for the years prior to 1846, bills for the earlier period are especially valuable.

Records in Document Box:

Arrangement: These records were received by the County Archives in a group and were processed separately. They help fill in some of the missing dates in earlier records. Many of these bills were numbered (by hand) consecutively but no relationship was found with the supervisors' minutes (Series .026) where many of approved expenses are listed in a numerical order. These records are ordered chronologically and not in their numeric order. Also, it is unknown why and who and when these papers were numbered. Some numbering appears contemporary to the documents, other appears to be much later. The records prior to 1877 – but not all of them – are numbered. In 1877, they seem to have switched to a lettering system, and many receipts/bills are identified with a letter. There appears to be a direct connection with series .094, ledgers from the treasurer's office which start with volume A in 1877. Some of the receipts in series .007 match the letter designations in these volumes.

Description: These are mostly bills presented to the county and receipts. Included are purchases, military, poor house, NY State, towns, district attorney, schools, constable, judge, witness, justices, jury, sheriff payroll, clerk payroll, judgments, Putnam County National Bank checks, prisoners board, circulars, state (tax) receipts, roads, bounty on foxes, jail repair, food bills for poor house, asylum bills from upstate and out of state. One folder of military receipts, 1849-1866 gaps, has been segregated because of the special interest of some researchers. There are likely more that are still mixed in.

Due to the nature of receipt (somewhat piecemeal) of these records and its influence on subsequent processing, records of several established series are mixed – treasurer, county bills, and loan commissioners' records, or reference thereto, may all be found in 007, .021, 025, 026, 033, and 094.

Description: The deeds in the volumes (libers) are *copies* of signed original deeds left with the county clerk when they were filed. Some were never picked up from with the county clerk after they were copied, and they are to be found in this archives box.

will include the following: date. name(s) of the grantor (person selling or giving the real property), the grantee (person receiving the property), description of the parcel with metes and bounds, including, frequently, the names of neighboring property owners. The selling price may be given as well as any conditions of sale. Metes and bounds are often difficult to understand, particularly because measurements (chains, links, etc.) are unfamiliar and because surveyors' landmarks (e.g., chestnut tree, pile of rocks, etc.) have disappeared. The Historian's Office has instructions on how to read and understand metes and bounds in a deed.

Description: Deeds collected in document boxes are original, signed deeds that were copied into the libers. As only a few of the deeds transcribed in the libers were retained in the county clerk's offices. Apparently, these deeds were never collected by their owners after they were recorded. At the beginning of DB#1, there is a folder of deeds without the libers or page numbers noted. Most date from 1812 and were recorded in Liber A. The second folder in this box contains deeds of land bought and sold by Jonathan Morehouse, some from outside the county or state. There is no recording information on them, but they must have been his personal papers kept by Morehouse in the clerk's office and left there. He was county clerk from 1822-1836.

The Overseer prepared these annual reports for the Secretary of State to show accounts of allowances owed by the County to the Overseers. The reports also contained the roster of persons residing at the Poorhouse. The indentures for apprenticeship placed children in private homes, where they would be taught a trade or skill. In exchange for their labor, children were to be educated, clothed, and provided with occupational training until they reach their majority, 18 for females and 21 for males. While most of children are between 10 and 14, some indentures document that children as young as 3 years old were placed in this manner. Some children were indentured by the Overseers of the Poor and others by their parents. The indentures are in two folders arranged chronologically.

Description: The series contains the records of the overseers of highways and commissioners of roads. During the 19th century, roads were laid out by commissioners of roads in each town, and compensation was paid to those landowners whose property was taken for a public road. People who believed that they were inadequately compensated for their land might appeal to the Court of Common Pleas. At each annual town meeting, pathmasters were appointed to maintain set portions of roads in their towns, using their own draft animals if necessary. Pathmasters usually owed a day or two of labor. Those who did not perform their required work and non-resident owners and businesses were assessed an amount of money in lieu of labor. Between 1907 and 1909, each of Putnam's towns adopted the "money system" whereby taxes instead of labor were levied on property owners for the maintenance of roads.

Description: This series contains petitions to, licenses issued by, and bonds in favor of Commissioners of Boards of Excise to sell liquor in taverns and inns (where it would be consumed on the premises), in grocery stores (where the liquor was consumed off the premises), and in stores where liquor was sold for medicinal purposes. In the early licenses, licensees swear that they will not keep a disorderly tavern or inn or permit cockfighting, playing with cards or dice, keep any billiard, any other gaming table or shuffleboard. The certificates note name, location, and type of establishment and cost of permits. The cost varies according to nature of the selling of liquor such an 'ordinary' store (cash and carry) or a tavern or inn where the liquor would have been consumed on premises. There are some annual reports from the Commissioners of Excise and petitions to the commissioners to grant and not to grant licenses. Note also 1919-20 IRS approval during Prohibition in both Southeast and Carmel.

By an 1881 ordinance, the Board approved the establishment of a fire district in the Village of Brewster to "procure a supply of water and apparatus."

known connections with other 'bond' series (092, 142-145), but there remains unprocessed material. Series 093 may be an index to Series 004 or an index for undertakings. This is not yet verified.

This collection of demographics is good source of for tracking family histories, immigration and naturalization, community studies; business, residential grouping by nationality, etc.

Since this data spans the economic period of the turn-of-the-century prosperity, World War 1, and the Great Depression era, it may offer compare/contrast evidence into the economic and social trends of a primarily agricultural economy.

This volume is such a modest offering of registrations it seems suspect that so few farms were registered in this period. A possible explanation for this may be found if the researcher would examine Series 104, Assumed Name Register, for growth of non-farm businesses in the same period.

Description: In the 1980s, garbage companies and garbage districts throughout the county were finding few places for disposal of solid waste because landfill space was becoming scarce and expensive, and the state was closing substandard landfills and dumps. Seeking a county-wide solution, the county engaged the firm of William F. Cosulich Associates of Woodbury, NY, to develop a Solid Waste Management Plan, which was finalized in 1989. Ultimately, the site selected for a landfill in Patterson created such an uproar that a county executive who supported the plan was defeated in a primary election in 1990 and the legislature rescinded its earlier vote to approve the plan. The series also includes subsequent plans and solid waste reports prepared for the county.

- **Box 1.** This series includes the Cosulich plan, an analysis of the waste stream, recycling and separation, and the siting of a landfill.
- **Box 2** The generic, draft and final Environmental Impact Statements filed in compliance with the NYS Environmental Quality Review Act of 1975, and statements and studies from opponents of the plan.

The "order of the court" record shows the date admitted to citizenship or the reasons for petitioner's denial. The certificate is numbered and dated. In a number of records additional documents relating to the original application are appended to the petition. This collection of volumes contains approximately 90% male petitioners and 10% female petitioners.

The record shows demographic information, simple inventory or complex inventories through a series of schedules. Surrogate's Court minutes record the process of probating a will, *e.g.* granting letters of administration, appointing guardians, examination of witnesses, etc.

Description: Since 1882, marriages have been recorded by town and village clerks. During this period only (1908-1936) they were also filed with the County Clerk.

The Marriage records begin with volume Ø 1908-1918 as a simple recording of the Groom and Bride. Beginning volume #1 the format changes to 3-part form, the License, the Certificate, and the Affidavit. The first form is the marriage license, stating basic demographic information such as name, address, age, occupation, parents name and county of origin, color "race", number of marriages, widow or divorced, and a statement referring to a testimony for "not" having a venereal disease. The second is the Marriage Certificate stating the person who performed the ceremony, date, place, and witnesses. The third is the Affidavit for the license to Marry, a brief form repeating the same demographics. The fourth is a Certificate of Consent and is only required if one of the parties is under the age of 21.

Note: These volumes may be used as an index to locate documents in Series 070, Marriage licenses and certificates. The information recorded is the same in both places, except for the title of the person performing the ceremony which is more likely to be included on the individual forms. Both certificates and volumes appear to be filled out by the clerk – except box #1. To search by name, use database MARRIAGE.DTF or Master Name Database.

Description: The series consists of deeds by the New York State Commissioners of Forfeitures to lands forfeited by landowners who had been found guilty of treason for their adherence to the British Crown during the American Revolution. Most of the land sold in what would become Putnam County were in six of the nine lots owned by patentees Susannah (Philipse) and Beverly Robinson and Mary (Philipse) and Roger Morris. The deeds as recorded are the documentation with metes and bounds of forfeiture sales by to various purchasers, most of whom supported the patriot cause or who were, at least, neutral. This volume is a photocopy; the original is in the Dutchess County Historical Society collection.

NOTE: To better understand this volume, the size of the parcels, abutting landowners, etc., consult the Henry S. Concklin maps (1887) located in the archive Map Collection. The Conklin maps were created in 1887 from surveys drawn from the forfeiture deed descriptions. New York City protested the assessed valuation of its property in Putnam County – water works improvements related to the reservoirs were included in the valuations and New York City argued that they should not. The valuations were upheld by the courts, the City appealed, compromise was finally reached in 1939. Starting in 1897 in Southeast, protests seemed to have been filed against each town respectively every year until settlement.

Testimony may be found from engineers, commissioners, officials of the Aqueduct Commission, Board of Water Supply, and other offices as well as people involved in real estate, accounting, etc. and local individuals such as D. H. Knapp, A. E. Nichols, D. F. Valentine, A. S. Burgess, E. Wegmann, E. F. Joyce, A. E. Budd, O. and W. F. Bailey, E. G. and G. W. Horton, G. W. Birdsall, J. E. Tower, and others.

Much interesting insight is contained in the various testimony about the construction of the dams and aqueduct of the New Croton water system and the magnitude of the entire project.

Jurisdictions include: New York Supreme Court, Appellate Division, 2nd Judicial Department, Brooklyn; Supreme Court, 9th Judicial District; 2nd Judicial District, and possible others.



Property was sold to the highest bidder at advertised public auctions at what was known as a *public vendue*. The successful bidder on real property was entitled to obtain a deed for the property in fifteen months unless the debtor redeemed his or her property by satisfying the debt or judgment within that time. The vendue was usually held in the county clerk's office. On a few occasions, the certificate was issued by a county coroner, not the sheriff.

Description: Following the 1979 accident at the Three Mile Island Nuclear Generating Plant in Pennsylvania, the operators of the nuclear power plants at Indian Point, Buchanan, NY developed emergency evacuation plans for the area within ten miles of the plant. This area includes parts of Philipstown, Putnam Valley, and Carmel. Working with the emergency service agencies in each affected county, the operators (Consolidated Edison, the New York State Power Authority, and Entergy) planned evacuation routes, procedures, and shelters for evacuees. Booklets were mailed annually to each household within the evacuation area to inform residents of what they should do and where they should go in the case of an emergency at the nuclear plant or a weather emergency requiring evacuation. The plant at Indian Point was closed in May, 2021, and was to be decommissioned by Holtec.

Description: The Carmel Police Department maintained 2 "End-Bound" Record ledgers. Both books are leather bound black books with maroon trim at the top and bottom. Both books were used as telephone call logs to the department. All entries are dated and include the time of call

and a brief description of caller and reason for call. Many of the entries end with how the call/complaint was handled and the resolution. Most entries are written in pencil.

The reasons for the calls most commonly noted were: missing pets (dogs and horses); dog complaints; suspicious individuals spotted on private property; auto accidents, post offices requesting money escort from officer; drunk driving; noise complaints; and trespassing on private property

Book 1 contains entries from January 1, 1950 – December 31, 1952. The book is in good condition other than entries are written in pencil and several of the pages have smeared or smudged are difficult to read.

Book 2 contains entries from January 1, 1953 to September 1, 1956 at which time an entry was made that a new book is being used. The condition of this book is not as good as book 1 as the spine is ripped and falling apart.

Description:

The Putnam Valley Town Clerk made available to the Historian's Office digital scans of the vital records that may be accessed by researchers. This series contains records printed from the scans. They are the records of births, marriages and deaths that occurred in the Town of Putnam Valley. For a brief period in the 1840s, town clerks kept these records, but only after 1882, were they required to by state law. Persons interested in more recent vital records may apply to the Putnam Valley Town Clerk.

Birth Records, 1847-49, 1882-1937 (4 folders) Birth records list name of child, date of birth, gender, number of previous children of mother, number living, color (if other than white), place of birth, maiden name of mother, married name of mother, mother's birthplace, name of father, father's occupation, father's age, father's birthplace, medical attendant, date of registration.

Death Records, **1847-1849**, **1882-1863** (5 folders) Death records list date of death, name of deceased, age at death, marital status, race, birthplace, length of time resident in Putnam Valley, Father's name and birthplace, mother's name and birthplace, place of death, cause of death, "time from attack till death", medical attendant, place of burial.

Marriage Records, 1847-1849, 1882-1963 (3 folders) Marriage records list date of marriage, information on husband (full name, residence, age, race, occupation, birthplace, 1/3/2023

father's name, mother's maiden name, number of previous marriages, and information on wife (full name, including maiden and married names, residence, age, race if other than white, birthplace, father's name, mother's maiden name), the name and official position of person solemnizing the marriage, and date of registration of the marriage.



Series 200 Chattel Mortgages. 1834-1863

Extent: 97 items in 5 folders in shared DB A2-U2-S5-11

Arrangement: numeric by added numbers in pencil

Description: Chattel mortgages are debts secured by personal property rather than real property. They were filed with the County Clerk but not entered in the mortgage libers. These records span the years from 1834 to 1861, with most borrowings occurring in 1837, the year of a nationwide financial panic. The items of personal property most frequently pledged were horses and conveyances, oxen, farm equipment, dry goods and store merchandise. Benjamin Baily secured his loan with his law library among other items, and hotelier Lewis Gregory pledged boats and furnishings of his hotel. A separate folder contains three lists of mortgages (1) numerically; (2) by last name of debtor(s), and (3) by last name of creditor(s).



Series 201 Mortgage Foreclosures and Sales, 1837-1897

Arrangement: roughly by year

Description: Upon the failure of a mortgagee to make required payments on an outstanding mortgage, the mortgagor may foreclose on the debtor's property. Some of the mortgages have been assigned to a third party. Most of these records consist of legal notices cut from newspapers and pasted on an affidavit signed by the county clerk attesting that the foreclosure sale was duly advertised. Occasionally the original mortgage and its filing information is attached.



Series 202 Superintendents' Record of Teaching Licenses, 1888-1896

Extent: 1 volume A2-U2-S5/12

Arrangements: chronological within license types

Description: This book is what remains of a volume of forms used for first, second, and third grade teaching license certificates. The certificates were torn out, and the stubs remain. The binding was cut

down after the book was filled. Presumably, the book of forms was issued by the NY Education department and used by the county superintendent of common schools who issued the licenses to teach. The information in the stubs (though not always filled out) included the name of the licensed teacher, the date, teacher's home post office, age, the number of terms he/she has taught, and the scores on the examinations for each grade.

For a Third-Grade certificate, the teacher was examined in eight subjects: Arithmetic, Composition, Geography, Grammar, Orthography, Penmanship, Physiology and Hygiene, and Reading. Subjects were added for a Second-Grade certificate: American History, Civil Government, Current Topics, Elementary Drawing, and Methods. A First-Grade certificate examination included still more topics: Algebra, Bookkeeping, Composition, Elements of Physics, and School Law, as well as all those in the other examinations. Scores are usually included on the stub.

It appears that relicensing at the same level was require every five years, but a teacher could move up sooner by taking a higher examination. This book was turned over to the County Historian by the Putnam History Museum in 2013.

Description: Following the adoption of the County Charter in 1978, the Administrative Code was adopted by the new legislature to define the functions and organization of each county department. The administrative code authorized the personnel for the departments, including job descriptions, appointment procedure, union status, relationship to the county executive, legislature, and department head, and the authority from the state, if any, for the department's existence. The code was adopted by the legislature on August 16, 1983.
