# REGULAR MEETING OF THE

# PUTNAM COUNTY LEGISLATURE HELD VIA AUDIO WEBINAR PURSUANT TO TEMPORARY EMERGENCY ORDERS

Wednesday November 4, 2020 7:00 P.M.

The meeting was called to order at 7:03 P.M. by Chairwoman Addonizio who led in the Pledge of Allegiance and Legislative Prayer. Upon roll call, Legislators Montgomery, Gouldman, Nacerino, Albano, Jonke, Castellano, Sayegh, Sullivan and Chairwoman Addonizio were present. Also present was Legislative Counsel Firriolo.

# **PROCLAMATIONS**

Chairwoman Addonizio stated that the following proclamations are for informational purposes and will be mailed to the relevant parties.

## NATIONAL RUNAWAY PREVENTION MONTH

WHEREAS, National Runaway Prevention Month began in 2002 and is spearheaded by the National Runaway Safeline (NRS), the Federally designated National communication system for runaway and homeless youth; and

WHEREAS, the prevalence of runaway and homelessness among youth is staggering, with studies suggesting that every year, 4.2 million people ages 13 to 25 endure some form of homelessness; and

WHEREAS, runaway youth are often expelled from their home, have experienced abuse and trauma, are involved in the foster care system, are too poor to secure their own basic needs, and may be ineligible or unable to access adequate medical or mental health treatment; and

WHEREAS, children and youth who run away are at increased danger for falling into high-risk situations, including human trafficking; and

WHEREAS, effective programs supporting runaway youth and assisting youth and their families in providing safe and stable homes, succeed because of partnerships created among families, youth-based advocacy organizations, community-based human service agencies, law enforcement, schools, faith-based organizations and businesses; now therefore be it

RESOLVED, that the Putnam County Executive and the Putnam County Legislature do hereby proclaim November 2020 as National Runaway Prevention Month. We urge all citizens to support the effort to increase public awareness about, advocate on behalf of, and provide positive and safe alternatives to runaway and homeless youth and their families.

Item #6a – Approval/ Budgetary Amendment (20A063)/ Finance/ Bureau of Emergency Services/ 2019 Statewide Interoperable Communications Grant (SICG) Award was next. Chairwoman Addonizio recognized Legislator Castellano, Chairman of the Audit & Administration Committee. On behalf of the members of the Committee, Legislators Gouldman and Sayegh, Legislator Castellano moved the following:

Legislator Montgomery stated that there have been a lot of discussion about the radios and her constituents are concerned. She stated that a Deputy Sheriff, which is her constituent, was stabbed. She questioned how this funding relates to the \$10 million project. She questioned what it would be used for.

Legislator Castellano explained that it would have been a good question to ask during the Committee meeting. He explained that we are receiving these funds for the Interoperable Radio Project.

Legislator Montgomery stated that she did not have this question then. She questioned why we have this meeting if we cannot ask questions or know what we are moving forward.

Legislator Castellano stated that she could vote against it.

Legislator Sullivan questioned why it was mentioned that a Deputy Sheriff was injured during this topic of the Interoperable Radio Project grant. He explained that there has been nothing received from the Sheriff's Department and he did not know of a relationship between these two (2) issues.

Legislator Albano believed that questions should be brought up during the Committee meetings when Department Heads are available to answer these questions. He believed that it was only on the Full Legislative agenda because concerns have already been addressed.

Legislator Castellano stated that the grant application is in the Legislative office for review.

Legislator Montgomery stated that she would ask questions whenever she wants to. She was not sure if Legislator Sullivan was aware that there was a PESH violation filed by the PBA because of the radios. She stated that because of the stabbing incident the County paid a violation. She stated that she would address a memo to the County Executive requesting what this \$590,058 will be used for.

# APPROVAL/ SEQRA / NEGATIVE DECLARATION/ STONELEIGH AVENUE/ DREWVILLE ROAD INTERSECTION RECONSTRUCTION PROJECT (PIN 8761.97)

WHEREAS, the Putnam County Legislature is considering the approval of a Putnam County Highways & Facilities project that involves the reconstruction of the intersection of Stoneleigh Avenue and Drewville Road into a single lane roundabout. The purpose of the project is to improve overall traffic conditions while reducing delays, thereby improving access for emergency vehicles to the Putnam Hospital Center located a half mile south of the intersection. As part of the reconstruction, a fill type retaining wall will be constructed on the western approach with significant grading on the eastern approach. The work will allow the road to be graded away from the intersection to provide a flatter approach as drivers enter the roundabout. New drainage and stormwater systems will also be constructed. The stormwater improvements include a new detention pond, modifications to an existing pond, dry swale, and hydrodynamic separators. The closed drainage improvements will eliminate future erosion that continues to damage the existing shoulders of the intersection. There will also be miscellaneous improvements to guiderails, signage, and landscaping; and

WHEREAS, the proposed action is subject to review under the State Environmental Quality Review Act and the Regulations promulgated thereunder ("SEQRA 6 NYCRR Part 617"); and

WHEREAS, on September 1, 2020, as part of Resolution #20-149, the County Legislature issued an Unlisted Action determination for the above referenced project, and declared its intent to serve as Lead Agency with respect to SEQRA; and

WHEREAS, a Full Environmental Assessment form (EAF) was prepared for the Project; and

WHEREAS, the EAF and associated documentation was circulated to all involved and interested agencies for the requisite 30 days with a Notice of the Putnam County Legislature's Intent to Serve as Lead Agency and no objections were received thereto; and

WHEREAS, the Putnam County Legislature, acting as Lead Agency, conducted a coordinated environmental review in accordance with §617.6, and

WHEREAS, based upon a careful review of the action as a whole, of the EAF, and the criteria set forth in 6 NYCRR Part 617.7(c), it has been determined that the proposed Project will not result in any potential significant adverse environmental impacts; now therefore be it

RESOLVED, that the Putnam County Legislature, as Lead Agency, determines that the proposed Project will not have any potential significant adverse impacts and a Draft Environmental Impact Statement will not be prepared; and be it further

RESOLVED, that in accordance with 6 NYCRR Part 617, the Putnam County Legislature, as Lead Agency, hereby accepts and adopts the Negative Declaration prepared in connection with Stoneleigh Avenue/Drewville Road Intersection Reconstruction project, a copy of which is annexed hereto and made a part hereof; and be it further

RESOLVED, that this Resolution shall take effect immediately.

BY ROLL CALL VOTE: ALL AYES. CARRIED UNANIMOUSLY.

# Item #8 - Recognition of Legislators

Legislator Albano stated that we all have the right to ask questions, however, he believed to ask questions during a Full Legislative meeting we will not have an answer because the individuals that can answer these questions are not here to do so. He explained that during Committee meetings the Department Heads are available to answer these questions, and if not, we can get those answers before the final vote is taken. He believed that procedurally that was the proper way to do it.

Legislator Montgomery explained that it was not in anyone's purview to tell her how she should do her job. She explained that she will ask questions when she wants to. She stated that she will continue to ask questions as they come up, and as the Legislators know, she stated that she asks questions during the Committee meetings as well. She stated that she does what the people of her district want her to do.

Legislator Nacerino congratulated all the victors on Election Day, especially her colleagues; Legislative Chairwoman Toni Addonizio, Legislators William Gouldman and Amy Sayegh. She stated that she is proud to serve with them on the Legislature.

Legislator Sullivan stated that he would like to echo Legislator Nacerino's comments. He stated it was great to see the record number of people who came out to vote.

Legislator Jonke stated that two (2) weeks ago we lost two (2) Putnam County residents in a car accident; one (1) who was a member of our Sheriff's Department SPO Program, Deputy Michael Moore. He asked that we keep their families in our thoughts and prayers.

Legislator Montgomery also congratulated her colleagues; Chairwoman Addonizio, Legislator Gouldman and Legislator Sayegh. She stated that she enjoys serving with them in serving the people of Putnam County. She also thanked Senator Peter Harckham for all his hard work for Putnam County and she was sorry to see him go. She stated that she is looking forward to working with Senator Elect Rob Astorino. She also congratulated the other Putnam County representatives who won the election. She stated that she looked forward to a new and different year as we enter the second phase of this pandemic and economic crisis.

Legislator Sayegh stated the Moore family has been friends of her family for years and they are her constituents. She stated that it was her great honor to serve our community, and each and every person in it. She stated that it is not about partisan politics; it's about doing the right thing and standing up for what you believe in and doing your best to be a role model for the next generation. She thanked everyone for their support.

Legislator Castellano explained that we just had an interesting election yesterday. He was looking forward to this Country remaining peaceful through this process and he hopes that every vote is counted. He thanked Senator Harckham for duties to Putnam County in the past. He stated that the election is not yet finalized, so we do not know who the victor is at this moment. He wished everyone the best. He stated that Veteran's Day is next week, and he wanted to thank the Veterans. He encouraged everyone to promote their Veteran's Day Ceremony in their towns. He stated that he looked forward to being outdoors again at the local ceremony to thank all the Veterans for the great

things they have done. He stated that Thanksgiving Day is also celebrated in November. He stated as Americans we have a lot to be thankful for. We live in the greatest Country on the planet. He stated that he is looking forward to continuing greatness with this Country and the County of Putnam.

Chairwoman Addonizio thanked her constituents for their overwhelming support. She stated that it is her honor to serve the people of Putnam County.

There being no further business, at 7:33 P.M., Chairwoman Addonizio made a motion to adjourn; seconded by Legislator Castellano. All in favor.
